Research Data Alliance - RDA

The Research Data Alliance (RDA) was launched as a **community-driven** initiative in 2013 with the vision that **researchers and innovators can openly share and re-use data across technologies, disciplines, and countries to address the grand challenges of society.**

The RDA's mission is to **build the social and technical bridges** that enable that vision, accomplished through the creation, adoption and use of the social, organisational, and technical infrastructure needed to **reduce barriers to data sharing and exchange. Scientists & researchers join forces with technical experts** in focused Working Groups, exploratory Interest Groups and Communities of Practice.

Individual membership is free and open to all.

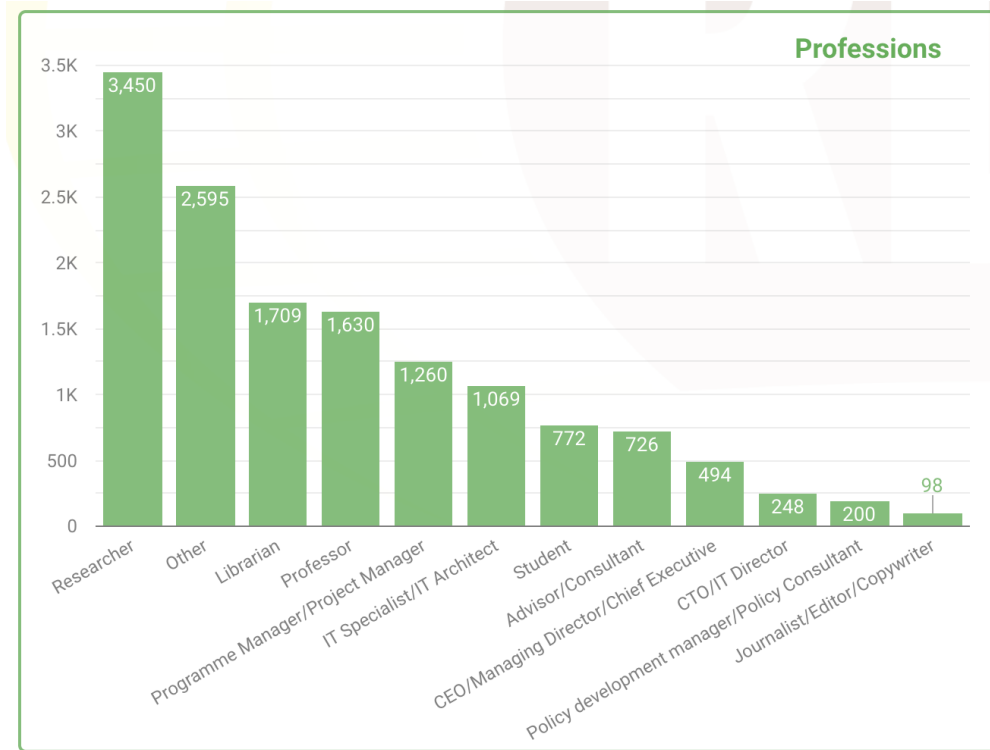

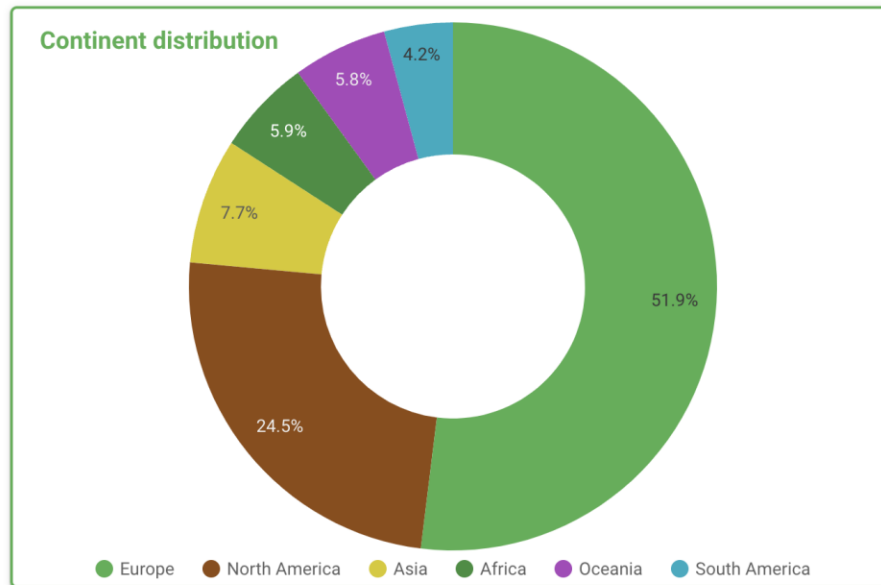
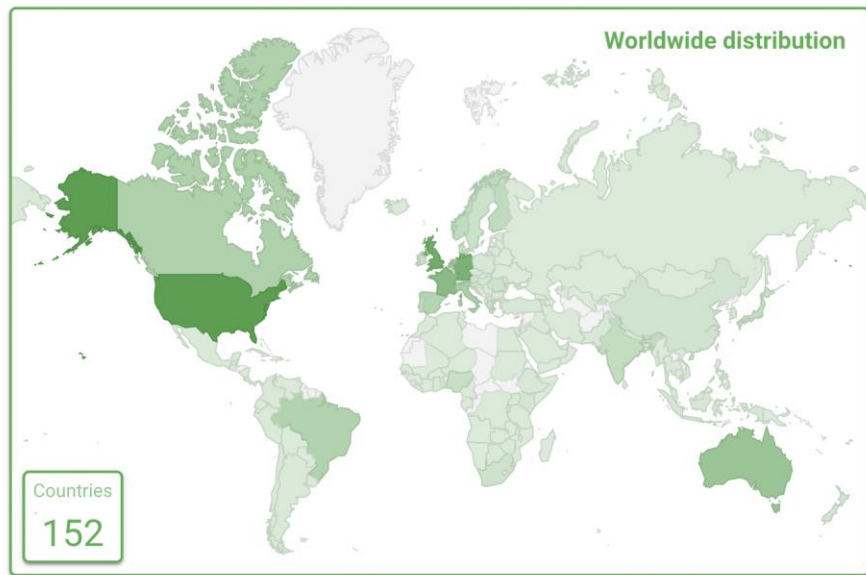

Who is RDA – Geographical Distribution

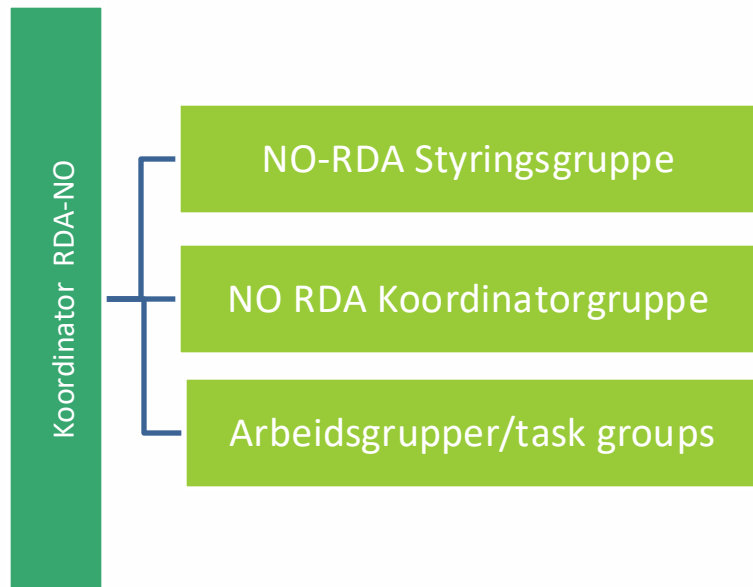

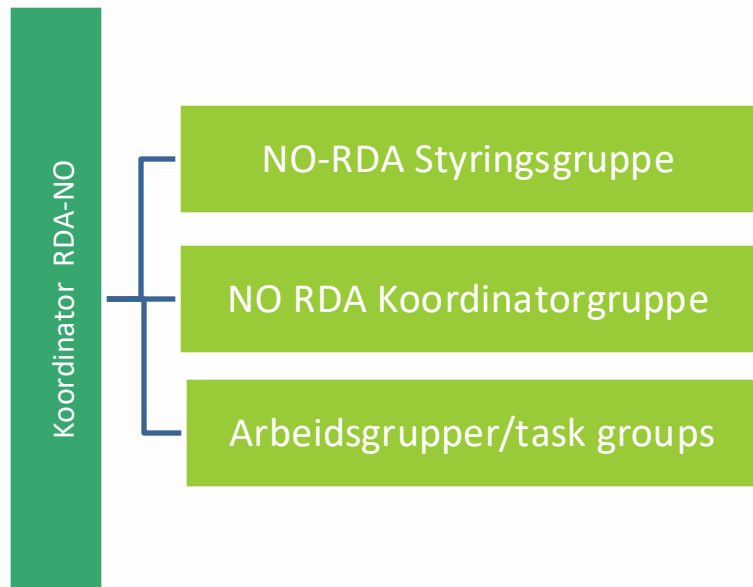

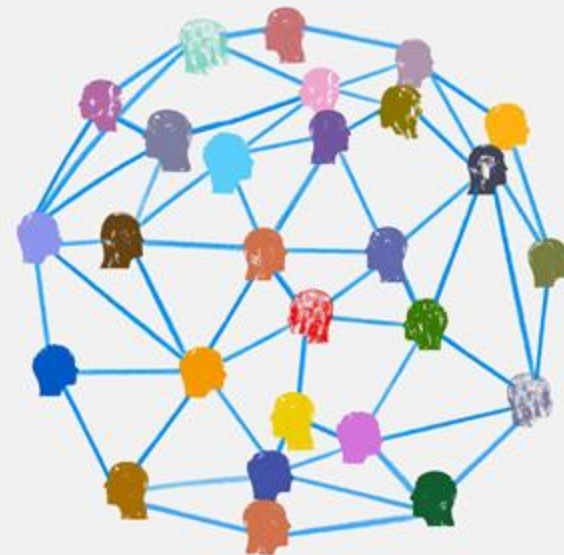
Become an institutional member!



- The possibility to influence policy and practices
- Establish **networks** and foster **collaboration** across institutions and other relevant partners in the RDA network
- **Capacity building** and sharing of **best practices** and a common understanding
- **Promoting Open Science**
- **A bottom-up network:** most of the tasks done by the task groups are based on challenges encountered by research support and researchers- with the aim to resolve them

Requirements:

- Annual fee (currently 10.000 NOK per year)
- A representative in the steering group (*management level*)
- A representative in the Coordinator Group (*operational level*)
- Willingness to be an active participant in task groups (*can be anyone from the institution*)
